To the Northville City Council and City Manager George Lahanas,

I am a building and business owner in Northville's Central Business District (CBD). I have heavily invested, through the assessment of mandatory parking credits, to pay for the provision of public parking in the CBD. Some of us have paid almost a quarter of a million dollars, without complaint, to ensure that our staff and/or clients may park nearby.

Three factors have recently caused us to question the fairness and veracity of the city's provision of this function that we have paid heavily for the past five decades. (Please keep in mind, currently a single space parking credit has run as much as \$15K.) Those three factors are:

1 – The loss of on-street parking spaces (approximately 42) during past street closures (four years so far) and at least half of 2014 moving forward under the 4/3/23 Seasonal Street Closure scenario of May to November. We have also lost parking spaces with the implementation of additional traffic controls, most recently on Cady Street. We are likely to lose the use of Cady Street parking spaces between Center and Griswold, starting in July for HPN development activities. The gravel lots have now been fenced off, bringing the estimated total of lost spaces to 300.

2 – Upon information and belief, the weightier factor is the impending loss of ninety-two public parking spaces when Hunter Pasteur Northville (HPN) purchases the parking lot on Cady. According to the Purchase Agreement HPN must "demonstrate how HPN shall replace the ninety-two parking spaces on property located within six hundred feet of the Northville Property in any direction which, by way of example, may include street and lot areas within the Development and on the Adjoining Property. These ninety-two spaces shall be in addition to the number of parking spaces required by Article 17 of City Zoning ordinance for the Development..."

3 – The striping of "new" parking spaces on streets not within 600 feet of the CBD is concerning, unlikely to be used by visitors or staff due to their increasingly remote locations (i.e., Griswold as far south as Beal St.).

Providing public parking is a mandatory function of the City Council and City Administration according to a Northville Zoning Ordinance which states: "The City shall assure the creation of parking and future parking for the CBD..." Further, the City Administration and Council need to provide the location of these ninety-two soon-to-be-lost spaces. We are aware of numerous residents (through citizen comments and letters inquiring about these spaces) yet public information has not been provided on this issue.

The lack of appropriate proximate parking impacts the function and value of our businesses. We request the location and map identifying the replacement of these ninety-two spaces **prior** to the execution of HPN's purchase of the parking lot property, as required by the purchase agreement and subsequent options/amendments, **or** receive refunds.

In addition, we are researching the filing of a Lis pendens order to protect our investment. I look forward to mutually informative and beneficial discussions on this topic soon.

Dear Mayor Turnbull and City Council,

We were disappointed to hear of the 6 month delay to close the downtown streets.

We hope the City will continue to pursue a street closure for Main and Center.

When we purchased our home in downtown Northville 29 years ago we understood we were moving to a downtown area. We understood that there would be traffic. We understood how our downtown was zoned and were careful to move to a part of the downtown that was a bit further away from the center of town. We understand that a strong downtown that people want to visit is good for our property values and have watched those values rise significantly over the last 29 years. A strong, walkable downtown with stores and restaurants we want to visit and events we want to enjoy is why we moved here.

The street closures made our town even more desirable.

You have listened to our concerns regarding traffic on South Rogers Street and have done a traffic study. When we are still unable to cross Rogers within the crosswalks you listened again and have purchased a pedestrian crossing sign to go in the street and await its installation. We have urged our downtown neighbors to take traffic concerns to the City Council and to the Police Department. Those who live in the neighborhoods are experts on their neighborhoods and understand the issues. We urge Council to continue to listen to what they have to say and offer reasonable traffic calming measures and acting swiftly to enact those measures. We also urge more policing in downtown, especially during high traffic hours in the morning and afternoon.

There were discussions in the past few years regarding changing the two parking spots on Main Street in front of Dancing Eye Gallery to drop off only. We would like to urge the City to consider this again as a convenience for businesses and those using those businesses. A repeated expectation from the Open the Streets group is that they want to be able to double park in front of businesses to drop off those with disabilities or with large packages. Of course this is illegal and causes traffic back ups. It's also dangerous for pedestrians and cyclists. We urge the City to be more strict with Police enforcement of parking and speeding laws. If we can get a ticket for forgetting to call in a license plate for one of our cars parked in front of our home overnight, the city can certainly ticket illegal parking and speeding in our downtown.

There are many residents downtown who had signs in their yards but many who did not. We do not want to argue with our neighbors who feel so strongly that the streets must stay open, but we also cannot remain silent when we disagree. There is a lot of change that has happened in Northville and much more change to come. We can't stop it so we need to consider how we can and must adapt. We acknowledge that people have different opinions, but filing a lawsuit was, in our opinion, taking it too far. It doesn't respect the democratic process of an elected government. There was much debate and our government made a decision based on significant input. We understand the City must respond appropriately to the litigation, and we support the city's position to fight this case.
